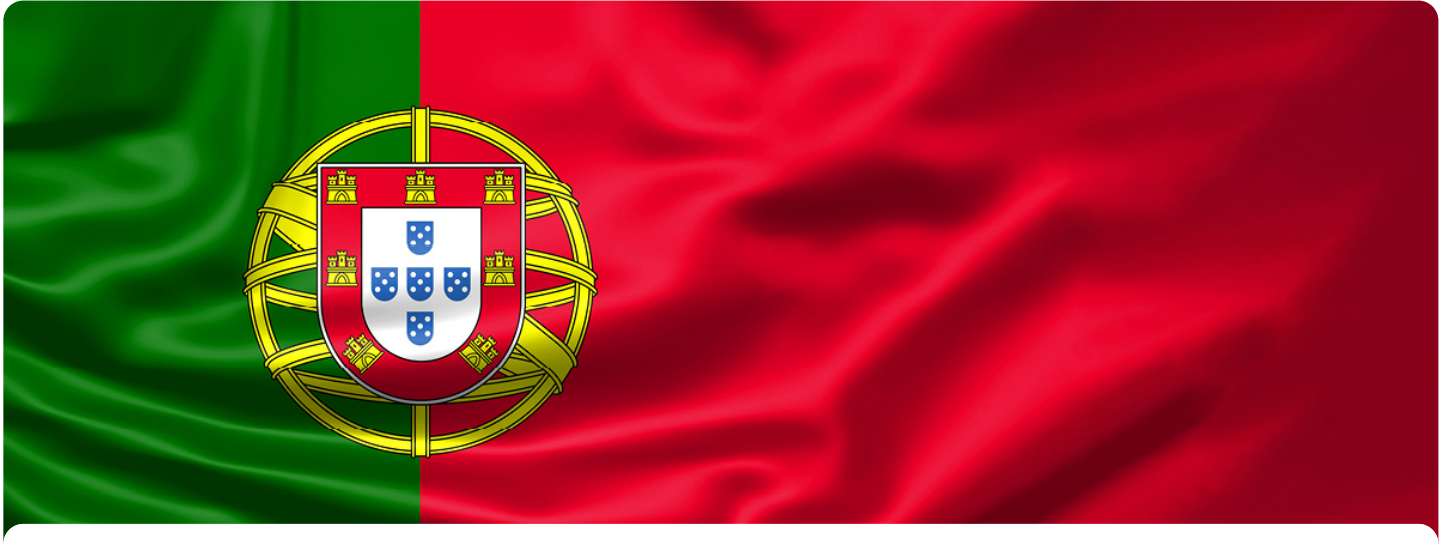

## *The Best Lawyers in Portugal™ Awards*

For 2023, we are proud to announce the 13th edition of *The Best Lawyers in Portugal*, in which 865 lawyers are recognized in 53 unique practice areas across four metropolitan areas. Lisbon is the metropolitan area with the most honorees. Along with individual lawyer awards, there are 44 "Lawyer of the Year" awards. "Lawyer of the Year" honors are awarded annually to only one lawyer per practice area in each region with extremely high overall feedback from their peers, making it an exceptional distinction.

For 2023, we are also excited to announce the inaugural edition of *Best Lawyers: Ones to Watch in Portugal*™. Eligibility for *Best Lawyers: Ones to Watch in Portugal* includes being in private practice and a tenure of three to eight years. With the same methodology that is used for *The Best Lawyers in Portugal*, our *Best Lawyers: Ones to Watch in Portugal* awards use an advanced process of nominations, peer voting and careful evaluation of results to provide a list of the top legal talent in the industry among newer lawyers. For the 2023 edition of *Best Lawyers: Ones to Watch in Portugal*, we recognize 139 lawyers in 19 practice areas. Lawyers are listed in 29 firms across 2 metropolitan areas.






